Late bidders shall not be accepted.

All bids must be complete. Total bids submitted higher than the approved budget for the contract (ABC) as indicated above shall be automatically disqualified during the bid opening. Late bids shall not be accepted.

Interested bidders may obtain information from BAC Secretariat, Supply Section – Municipal Treasurer's Office, Boac, Marinduque and inspect and request a copy of Bidding Documents from 8:00 AM to 5:00 PM excluding Holidays, Saturdays and Sundays.
